ADMINISTRATIVE ORDER NO. 18-2020

AND NOW, this 4th day of December, 2020, after a meeting with the Carbon County District Attorney on December 1, 2020, attended by the three Common Pleas Judges of this Court, at which the District Attorney advised the Court of the difficulties his office was encountering due to Covid-19 related staffing shortages and requested the Court to continue certain selected criminal events discussed at the meeting which have been scheduled for the remainder of this month, December 2020, and in consideration of this request and the impact of Covid-19 on the Public Defender's Office and the Carbon County Adult Probation Office, and in further implementation and refinement of the Eighth Amended Administrative Order No.6-2020 dated November 23, 2020, it is hereby

ORDERED and DECREED that the following criminal case events scheduled for December 2020, are continued by the Court to dates and times to be determined by Carbon County Court Administration in accordance with the following:

1. December 11, 2020: All Bench Trials scheduled for this date shall be continued, except for the case of Commonwealth v. Giacomina Solera, Docket No. 648 CR 2017, which shall be held as scheduled;
2. December 14, 2020: All Pleas scheduled for this date shall be continued. Formal Arraignments shall be held as scheduled. ARDs shall be rescheduled for December 21, 2020 at times to be designated by Court Administration;
3. December 15, 2020: All Sentencings scheduled for this date shall be continued. Formal Arraignments shall be held as scheduled. ARDs shall be rescheduled for December 21, 2020 at times to be designated by Court Administration;
4. December 17, 2020: All Sentencings and Gagnon hearings for non-incarcerated defendants scheduled for this date shall be continued. Gagnon hearings for incarcerated defendants shall be held as scheduled;
5. December 18, 2020: All Pleas scheduled for this date shall be continued. Formal Arraignments shall be held as scheduled. ARDs shall be rescheduled for December 21, 2020 at times to be designated by Court Administration;
6. December 21, 2020: All Pleas and Sentencings scheduled for this date shall be continued. ARDs and Formal Arraignments shall be held as scheduled; and
7. December 22, 2020: All Pleas scheduled for this date shall be continued. Formal Arraignments shall be held as scheduled. ARDs shall be

rescheduled for December 21, 2020 at times to be designated by Court Administration.

The foregoing Pleas and Sentencings scheduled for December 14, 15, 18, 21, and 22, 2020 shall be rescheduled by Carbon County Court Administration for the week of January 11, 2021, and/or on January 5, 18, 19, and 21, 2021. Those Sentencings scheduled for December 17, 2020 shall be rescheduled for January 4, 2021 in Courtroom No. 1 before Judge Nanovic at 10:00 A.M. and 11:00 A.M., and before Judge Serfass at 1:15 P.M. and 2:15 P.M., with the exact time for each case to be scheduled by Court Administration. Those Gagnon hearings for non-incarcerated defendants scheduled for December 17, 2020 shall be rescheduled to an appropriate date and time in the month of January to be determined by Court Administration. A list of all such cases and their docket numbers, as well as the continued bench trials for December 11, 2020, shall be prepared by Carbon County Court Administration and attached to this order. A copy of this order with the attached list shall be filed in the individual case file of all cases continued by this order and served on the parties and/or their counsel.

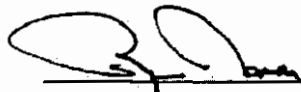
It is FURTHER ORDERED and DECREED that the Call of the Trial List scheduled for Monday, January 4, 2021, a list of which is attached to this order, is continued and shall be held in Courtroom No. 1 on Monday, January 25, 2021, at staggered times commencing at 9:00 A.M. for those cases scheduled before Judge Nanovic; commencing at 10:30 A.M. for the cases scheduled before Judge Serfass; and commencing at 1:15 P.M. for those cases scheduled before Judge Matika. Jury trials for the cases on this Call shall be held during the week of February 1, 2021. No later than January 25, 2021 by 9:00 A.M., after first confirming with defense counsel, the District Attorney shall provide

the Court with a list of no less than six cases which are ready for trial and for which it is reasonably anticipated a jury trial will be necessary to resolve the matter.

It is FURTHER ORDERED and DECREED that those Criminal Status Conferences scheduled for the mornings of January 18, 19, and 20, 2021, shall be continued and rescheduled for the mornings of March 15, 16, and 18, 2021, respectively. A list of these cases and their docket numbers shall be prepared by Carbon County Court Administration and attached to this Order, with copies of the Order and attachments to be filed in the individual case file for all Criminal Status Conferences continued by this Order, and copies served on the parties and/or their counsel.

Because the continuances made herein have been necessitated and caused by the impact of Covid-19 on the proceedings hereby continued, it is the intent of this Order that any delay caused in such matters be considered a Court postponement and shall constitute excludable time for purposes of the application of Rule 600. See Commonwealth v. Bradford, 46 A.3d 693 (Pa. 2012); Commonwealth v. Mills, 162 A.3d 323 (Pa. 2017).
