ADMINISTRATIVE ORDER NO. 2-2022

AND NOW, this 1<sup>st</sup> day of January 2022, pursuant to Pa.R.C.P. 1915.4-2 and in order to implement the Local Rules of Court relating to actions for child custody and visitation, it is hereby ORDERED and DECREED that DEBRA A. SMITH, Esquire is hereby APPOINTED Custody Master for custody and visitation proceedings effective January 1, 2022 until December 31, 2022. The Custody Master shall be compensated at the rate of FIFTY DOLLARS (\$50.00) for each Preliminary Conference actually conducted resulting in the filing of an interim order and SEVENTY-FIVE DOLLARS (\$75.00) per hour for a conference actually conducted resulting in a final order disposing of the case.

FURTHER, all custody cases open and pending that were previously assigned to Eileen Diehl, Esquire as Master are hereby assigned to Debra Smith, Esquire. A copy of this Order shall be filed and docketed to the original case file maintained by the Carbon County Prothonotary with respect to each case on the attached list and with any other cases subsequently identified in which Eileen Diehl, Esq. was assigned.
